

EXPRESSION OF INTEREST (EOI)

COLLECTOR'S RACK – PRINTS & WORKS ON PAPER

This Agreement is between UMI Arts and the Artist for the consignment and display of works for the **Collector's Rack – Prints & Works on Paper Under \$600** opportunity in the UMI Arts Gallery and Gift Shop.

This opportunity supports the presentation and sale of affordable original and editioned works on paper by UMI Arts members. Works will be displayed on the refreshed Find Art print display rack, positioned front and centre in the gallery gift shop.

TERMS AND CONDITIONS

- Artists must be current UMI Arts members and eligible under UMI Arts membership requirements.
- Eligible works include A1 size prints, drawings, etchings, photographs, mixed media works on paper, and other original or editioned paper-based works.
- All submitted works must retail for under \$600.
- Works must be professionally presented, ready for display, and suitable for handling in a gallery gift shop environment.
- UMI Arts reserves the right to select, display, rotate, or decline works at its discretion.
- The consignment period is from 1st July 2026 to 30 June 2027, unless otherwise agreed in writing.
- The Artist retains copyright in all submitted works. The Artist grants UMI Arts permission to photograph and reproduce images of the works for promotional purposes related to the gallery and gift shop.

SALES AND PAYMENT

UMI Arts will calculate the Retail Price using the Artist Price plus UMI Arts commission of 30%. The Artist will receive 70% of the sale price. Payments will be made to the Artist's nominated bank account within 30 days of the sale, subject to full payment being received from the purchaser and all required banking or supplier details being provided.

THE ARTIST AGREES TO:

- Provide accurate artwork information for each submitted work, including title, medium, dimensions, edition details where relevant, and Artist Price.
- Ensure all works are original or properly editioned, culturally appropriate, and do not disclose protected cultural knowledge.
- Deliver works to UMI Arts at the Artist's expense unless otherwise agreed.
- Provide works that are safely packaged and ready for display.
- Collect unsold works within 30 days of the end of the consignment period, or by the collection deadline advised by UMI Arts.
- Provide ABN and bank details, or a Statement by Supplier if applicable.

UMI ARTS AGREES TO:

- Present selected works in the UMI Arts Gallery and Gift Shop as part of the Collector's Rack opportunity.
- Manage display, sales, and administration for consigned works.
- Take reasonable care of works while in the possession of UMI Arts.
- Promote the opportunity and selected works through UMI Arts channels at its discretion.
- Arrange payment to the Artist in line with the terms of this Agreement.
